The provisions below represent the terms under which the US Christian Chamber of Commerce offers to your Christian Chamber (or Christian Business Associations operating like a Christian Chamber) the opportunity to be listed in our USC3 Directory. By accepting this offer, your Christian Chamber as a USC3 Directory Contributor aligns with USC3's mission to build Kingdom, business, and community.

2. Requirements and Conditions for a USC3 Directory Contributor

As with all other Christian Chambers listed in the USC3 directory, your Christian Chamber or equivalent as a USC3 Directory Contributor agrees to the following:

- a. Invite the Holy Spirit to be woven into the fiber and DNA of your Christian Chamber;
- Operate in an open and transparent professionally-run chamber, including having a minimum of 4 Directors on your Board of Directors (no more than 33% can be related persons);

- c. Operate with bylaws (see our template);
- d. Allow members to convene by hosting at least 1 Christian Chamber event per month;
- e. Keep an active directory for members to create Kingdom Commerce;
- f. Require all members to agree to a statement of faith (see our template);
- g. Create balance between business training, networking, and teaching and encouraging business that is based on faith and is honoring to God, while looking for opportunities to integrate business with faith at all events;
- h. At a minimum, commit to begin and end all chamber-related events with prayer;
- Create a serve-one-another atmosphere which is conducive to building relationships and creating a "know you, like you, pray for you, trust you, and do business with you" community culture;
- j. Be a neutral convener, inviting all to gather and build relationships equally without favoring or aligning with any one business or person. Sponsoring partners are allowed and encouraged;
- k. Operate with a Biblical Worldview, rather than a worldly ideology;
- Encourage your Chamber members to vote Biblical values in their communities, states and country, regardless of political affiliations. The Christian Chamber or CBA agrees to be a nonpartisan and nondenominational based organization with Christ at the center of it all.
- m. Right of first refusal if you decide you want to close your C3, you agree to provide formal notification to the USC3 rather than allow it to naturally attrit;
- n. Actively seek growth in membership, skills and spiritual depth.
- o. Attend at least 50% of our USC3 Christian Chamber Coalition virtual meetings with representation from your chamber leadership.
- p. Arrange for one or more of your members to attend the annual USC3 Expo workshop.
